This month we discuss international travel Covid-19 testing requirements, travel bans in response to the Omicron Variant, EB-5 regional center program update, as well as Trow & Rahal's holiday schedule, new staff, and monthly webinar.

International Travel Covid-19 Test Requirement

The CDC has changed the testing requirement to return to the United States after international travel. As of December 2, 2021, all passengers 2 years of age or older who are boarding a flight coming from a foreign country to the United States need to receive a Covid-19 test no more than one day before travel to the United States, regardless of vaccination status. Previously, it had been announced that vaccinated people could get a test within 72 hours and unvaccinated people had to test with 24 hours. Now everyone must test and show a negative result within the one day before boarding a flight to the United States. <u>Example</u>: If a person has a flight today at 5pm, the person can show a negative test taken any time the day before. It does not have to be within 24 hours but must be no more than one day before travel.

Alternatively, a person can show that they have recently recovered from Covid-19. This will require a letter from a licensed healthcare provider or a public health official indicating that the person is cleared for travel, along with a positive Covid-19 viral test result on a sample taken within 90 days before the flight's departure from a foreign country.

Reminder: The October 25, 2021, White House proclamation required all noncitizen, nonimmigrant travelers to the United States to be vaccinated against Covid-19 with limited exceptions. Travelers will need to show proof of vaccination to airlines. This vaccination requirement does not apply to U.S. citizens, permanent residents, or those traveling on immigrant visas (entering the United States for the first time as an immigrant). It also does not apply to children under the age of 18 and other limited exceptions enumerated in the proclamation.

Travel Bans Implemented in Response to Omicron Variant

The White House issued a proclamation on November 26, 2021, suspending and limiting the entry for certain immigrants and nonimmigrants who were physically present in the following countries: Republic of Botswana, Kingdom of Eswatini, Kingdom of Lesotho, Republic of Malawi; Republic of Mozambique; Republic of Namibia; Republic of South Africa; and Republic of Zimbabwe.

These travel bans do not apply to: Permanent Residents, Spouses of U.S. citizens or permanent residents, parents of U.S. citizens or permanent residents who are under age 21 and unmarried; siblings of U.S. citizens or permanent residents who are under age 21 and unmarried; and other classes of people as identified in the proclamation.

EB-5 Regional Center Program Update

Unfortunately, the extension of the regional center EB-5 program was not included in the stopgap spending bill approved by President Biden to avoid a government shutdown and fund the federal government through February 18, 2022. This extends the lapse in the EB-5 regional center
